

Clearfield Creek Watershed Association Minutes
September 17, 2002

- Call to order: Vice president John Strittmatter called the meeting to order at 6:40 followed by the Pledge of Allegiance.
- Secretary's Report: The minutes from the last meeting were read by Alene Smithmyer in Kara's absence.
- Corrections to last month's minutes: The shoot will be held on Sunday September 29. The constitution change is to meet Federal requirements rather than state requirements. The minutes stand approved as corrected.
- Treasurer's Report: The current balance in the regular account is \$3,864.78. The grant account has a balance of \$8,494.60 after paying Mahaffey Labs \$960.00.
- Finance Committee: The bill for the September 8 cleanup amounted to \$24.79 to be paid to Alene Smithmyer. The \$37.10 bill for the new style membership cards from Coalport Printing is to be paid to Debra Spaid. The \$425.00 bill for the hats and t-shirts is to be paid to Sean Bartlett. All bills were approved and paid.
- Membership Committee: There were no new members. The new membership cards are now available. Any active member can sell memberships and turn the money into the treasurer.
